Section 1: Background of HSSC

Healthcare Sector Skill Council (HSSC) is a recognized awarding body and implementation body of Skill India Mission under ambit of Ministry of Skill Development and Entrepreneurship constituted by key leading healthcare providers, pharmaceuticals, medical device industry, diagnostics, and associations from both public & private.

HSSC is engaged in the development of a robust and sustainable industry aligned quality skilling eco-system for healthcare sector including AYUSH, medical device sector, social sector and hospital management to bridge the demand and supply gap through skilling, reskilling and upskilling. HSSC aims to be an apex body for high quality skilling aligned to healthcare sector requirements, nationally and internationally.

HSSC closely works with Industry members, Healthcare Service Providers, Healthcare Training Organizations / Institutes, government, and policy makers to collectively facilitate the required change in the educational and training eco-system in the healthcare sector.

The Council is aimed to develop Qualifications, learning Resources, training programs required for Skilling, Reskilling and Upskilling of professionals required in the Healthcare Industry. Identify skill-gaps, Facilitate Industry Academia collaboration, Assessment & Certification Mechanism, Accreditation and Affiliations of Training Facilities, facilitate placement and Apprenticeship opportunities and guide institutes to build & upgrade facilities and Faculties.

Section 2: Broad Scope of Work

To impart increased standardization and quality in the training delivery of job roles in childcare economy, HSSC is aiming to develop standardized courseware based on Model curriculum and QP-NOS for following job roles:

A. The courseware would include but not necessarily be limited to the following forms:

A.1 Phase 1:

1. **Participant Handbook/Manual:** Inclusive of:

- content (textual, pictorial, graphical, tabular, flow-chart based, etc.) detailed as per the model curriculum
- self-assessment-based exercises and practical formulated for easy and comprehensive understanding of participants/students/candidates/individuals seeking to be trained for the particular QP-NOS.
- A section to be inserted for logbook or workbook-based guidance linked with HSSC prescribed assessment guidelines, properly sequenced in the order of difficulty levels and compacted with assessor/advisor/mentor feedback and comments
- There should be minimum **10 QR** codes embedded in each PH and FG. These QR Codes should be linked to videos/presentation of corresponding topics of the NOSs for elaboration of the topic and better understanding of the job role related skills. Obtaining permission to embed the videos will be the responsibility of the agency. The agency has to submit a letter of proof that they have obtained permission to embed the videos in the books, and the concerned owner of the video has “No Objection” to it. The bidding agency should take the onus. Videos will have to be approved with HSSC team, before embedding in the books.
- There should be an annexure of QR codes, as per the guidelines.

All needs to be developed as per HSSC prescribed format and requirements.

2. **Trainer's/Facilitator's Guide/Handbook:** Similar to Participant handbook, the Trainer's handbook needs to be developed with suggestive pedagogical methodology to deliver training to candidates. Inclusive of training delivery plans or lesson plans on day to day basis, daily schedule of events including visits/assessments/activities, suggestive notional learning hours per day, teaching aids or methods used per day and suggestive internal continuous assessment guidelines linking to final assessment guidelines.

3. **Assessment Guide:** Detailed Guidelines for assessor directly linked to HSSC prescribed assessment criteria inclusive of sample MCQs, Practical Skill sets and OJT handbook assessment guidelines along with infrastructure, equipment, logistic and pedagogical requirements prior, during and post assessment. A separate set of 300 MCQs, 3 practical skill sets per NOS and 10-15 viva questions for each NOS as per HSSC templates following HSSC prescribed assessment blueprint needs to be submitted.
4. **Translation into Hindi and 2 regional languages of above courseware**

A.2 Phase 2:

5. **E-learning Content for candidates:** E-learning Content in form of presentations and videos packed with vocal and animated linked to participant handbook/manual. Inclusive of Simulation Based Questionnaire at the end of each unit/module for self-assessment of candidates. The content desired to be converted into SCORM package to be hosted at HSSC LMS.
 6. **E-learning Content for Trainers:** Similar to e-learning content for candidates above linked to Trainer's/Facilitator's Guide, with added trainer notes and activities in suggestive pedagogical manner.
- B. Above all forms of courseware need to be developed closely with Content Approval & Technical Committee of HSSC as per HSSC prescribed/agreed format and requirements.
- C. Plagiarism checks along with requisite changes as per Plagiarism report to be completed till the final approved report (maximum to 5% which could only include general phrases & content from Govt./ permissible websites). At least two types of agreed plagiarism tools to be used for verification.
- D. Above all forms of courseware would be validated across country by at least 5 training partners and 10 industry partners. Release of courseware would be solely dependent on guidance and final validation of Content Approval & Technical Committee of HSSC.
- E. Copy right & IPR would be solely owned by HSSC for anything developed under purview of this RFP either given by HSSC or developed by Content Developer irrespective of the publishing of material.
- F. Any updation in the content based on learnings from the pilot implementation within the period of 1 year.
- G. While development of the courseware, the existing national/international courseware would be referred to, Subject matter experts would be consulted, and training institutes could be visited; deeply studied and assessed and best practices be taken into consideration.

- H. Along with courseware, documentary records of institute visits, validation forms, comments of the SME/validators, follow up mail and responses etc. and such like activities need to be maintained & submitted.
- I. Courseware needs to be submitted in Pdf, word and other open files (editable version) along with e-versions/e-books along with 5 sample printed copies of final versions as per the HSSC format and requirements.

Section 3: Terms & Conditions for Selection of Content Developer

A. The content developer needs to suffice following eligibility criteria:

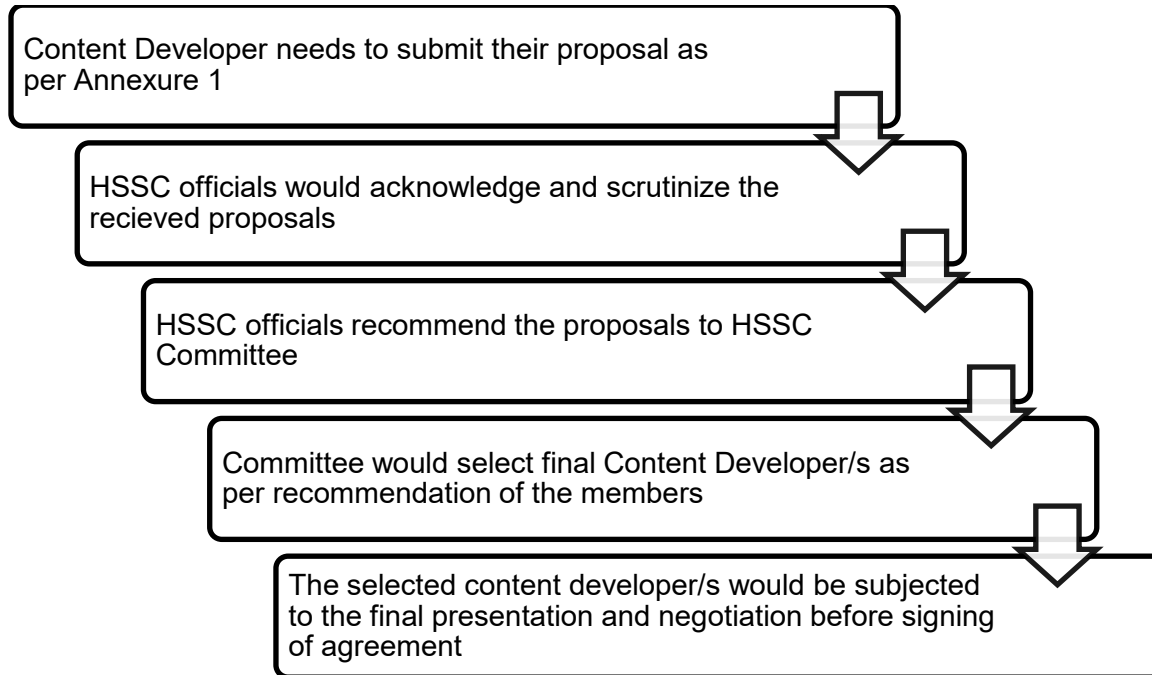
1. The organization should be a legal entity duly incorporated in India or abroad.
2. The organization should have appropriate credentials and experience of at least two years in providing services (in relevant area) to Central Government/State Government/Research or Academic Institution/ Public sector Companies/Undertaking/Autonomous Bodies/ Multinational Companies/Private Institutions and must have successful audit report for the aforesaid period.
3. The organization should have valid PAN/TAN/ Service Tax Registration/ VAT Registration as applicable and should submit a copy of each of the documents at the time of proposal submission.
4. Organization with experience of working in related sector in similar projects may have added advantage.
5. The organization should have demonstrated project management capacity with team members who possess relevant qualifications and experience in developing the courseware.
6. The organization with understanding and exposure to SSCs in India may have added advantage.
7. The organization should have the bandwidth to develop content for all Job Roles simultaneously.

B. HSSC reserves the right to carry out the capability assessment of the interested organizations and the decision of the HSSC shall be final in this regard.

C. The agreement would be withheld at any point of time, if the information furnished by the organization is found to be incorrect. The amount paid till that date should be returned within 15 days of the cancellation of the project contract.

D. HSSC may levy penalty charges in case of discrepancy in work, non-adherence to timelines or non-compliance to the terms and conditions of the work order.
